



## **DIVORCE COACHING /CONSULTING AGREEMENT**

### **AS YOUR COACH I MAY PROVIDE MANY SERVICES, SUCH AS:**

- Help to reduce the stress and anxiety of going through the divorce or family law process by talking through your fears and concerns. I understand this is a very scary and confusing time and I will help you sort it out so that it makes sense and you can move powerfully forward with the necessary legal decisions that have to be made.
- Help you learn new and efficient ways of communicating with your former spouse, children, attorney and other professionals who are involved in your case.
- Help you learn how to keep your child/children out of the middle using techniques and conflict resolution skills while creating appropriate boundaries.
- Help guide and manage your expectations.
- Provide you tools to control reactive responses.
- Interact with your attorney to create a support team for your legal case.
- Provide guidance, consultation and information to dispel confusion.
- Help you work towards being the person you truly want to be as a co-parent, parent, divorce client, employer/employee, etc.
- Create possibilities where you are able to do things perhaps for the first time that you never thought you could do.
- Envisioning a different life for yourself.

### **CLIENT'S RESPONSIBILITY:**

I ask that you come to Coaching with an open mind and a willingness to act in your child's best interest.

I ask that you allow me to interact with your attorney, or anyone else on your team when it would be helpful on your behalf, and with your knowledge. This includes consent for E-mail communication, phone contact, and in-office meetings.

I ask that you be prepared for any coaching sessions that are scheduled and assume you will call me at the appointed time. If you are more than 15 minutes late for a coaching call, I will assume the session is canceled and you will be charged for that session.

I also am available to you at other times whenever you feel you need to have a phone conversation, sent me an email to read and respond to, answer any questions, provide any feedback or advice on the best course of action for whatever you are dealing with. These times will be charged at my hourly rate in a 15-minute time period.

### **CONFIDENTIALITY:**

The coaching relationship is built on trust. The Coach agrees to keep all conversations and information with the Client private and confidential. No personal ideas, information or thoughts expressed will be shared with anyone except with the permission of the Client as authorized by the release form.

### **COACHING FEES:**

***Please note that I bill in 15-minute segments at \$300.00 per hour for all services provided.***

Client agrees to provide a credit card the Coach can charge for services rendered and/or provide a retainer in the amount of \$500.00 to be billed against. This retainer is also required for any clients desiring to pay via Venmo or Zelle.

Please be aware that there is a 24-hour cancellation policy. If you do not cancel within 24 hours and/or no-show for your appointment, you will be charged the full fee for the appointment time scheduled.
